The BPM Asia Star Championship: Guidelines For Submission of Applications

The BPM Asia Star Championship, 2018 award is available in two tracks:

a) BPM Asia Award for Enterprise Process Management

This award evaluates the breadth and depth of application of Business Process Management in the entire organization across 7 enablers as described in the application form.

Applicant companies are required to provide the detailed description of their process architecture in the relevant sections of the application form and attach relevant supporting material. The information submitted shall be used for initial screening. A company must score at least 300 points (on a scale of 500 points) for shortlisting. The Application form together with the application fee must reach the designated contact persons (see conference brochure) no later than 20 July 2018.

Applications should be filed in the Format : The BPM Asia Star Championship Application Form : ENTERPRISE PROCESS MANAGEMENT

The main evaluation shall be carried out by the jury based on the presentation made during the competitive section of the BPM Asia Conference, 2018. Presentations may use any format but it should provide the full information on the enablers detailed in the application form. Jury may use the written application and the supporting material submitted for reference and adjudication purposes. The duration for the presentation is capped for 20 minutes with Q & A by the jury for 5 minutes.

The Awards:

- The *BPM Asia Achiever Award* in the category of **Enterprise Process Management** shall be given to all applicant if they score in excess of 350 points.
- The BPM Asia Master Award in the category of **Enterprise Process Management** shall be given to the runner up, provided the applicant scored a minimum of 350 points
- The BPM Asia Star Award in the category of **Enterprise Process Management** shall be given to the winner, provided the applicant scored a minimum of 350 points

b) BPM Asia Award for Process improvement Project

This award evaluates : (1) the *quality* of process analysis and redesign approach using BPM tools, with special emphasis on innovative approaches used, and (2) the *impact* of the changes implemented as a result of the project.

Applicant companies are required to provide the detailed description of the Process Improvement Project in the relevant sections of the application form. The information submitted shall be used for initial screening. A company must score at least 300 points (on a scale of 500 points) for shortlisting. The Application form together with the application fee must reach the designated contact persons (see conference brochure) no later than 20 July 2018.

Applications should be filed in the Format : The BPM Asia Star Championship Application Form : PROCESS IMPROVEMENT PROJECT

The main evaluation shall be carried out by the jury based on the presentation made during the competitive section of the BPM Asia Conference, 2018. Presentations may use any format but it should provide the full information of the project together with the outcomes. Jury may use the information provided in the written application submitted for reference and adjudication purposes. The duration for the presentation is capped for 15 minutes with Q & A by the jury for 5 minutes.

The Awards:

- The *BPM Asia Achiever Award* in the category of **Process Improvement Project** shall be given to all applicant if they score in excess of 350 points.
- The BPM Asia Master Award in the category of **Process Improvement Project** shall be given to the runner up, provided the applicant scored a minimum of 350 points
- The BPM Asia Star Award in the category of **Process Improvement Project** shall be given to the winner, provided the applicant scored a minimum of 350 points

Applicants are strongly advised to keep their submissions lean and pertinent.
